Dear SGI Customer:

I am writing to advise you that production of new SGI® TP9100 [2Gb] will cease effective December 29, 2006. On December 1, 2006, SGI® TP9100 [2Gb] marketing codes will be removed from the SGI Price Book. Please refer to the attachment, which lists the systems that will be affected by this announcement. The intent of this communication is to inform you of changes to production, availability of product and how this will affect the service and support you currently receive on your SGI® TP9100[2Gb].

Once production terminates, SGI cannot guarantee the availability of new material. You will have the option of purchasing the SGI® TP9100 [2Gb] through our Remanufactured Products Division. These systems will be offered on an "as available" basis, and may be wholly or partly comprised of used or refurbished components. Please contact your local sales representative for more information.

SGI is committed to protecting your investment. While our policy is to support our products for five years after end-of-production [EOP], our goal is to support products as long as customers desire such support and as long as it's economically viable. To that end, SGI Technology Solutions has implemented a comprehensive process for establishing end-of-support [EOS] for our products. The projected end-of-support date for SGI® TP9100 [2Gb] is currently December 29, 2011. SGI service capabilities for end-of-production products are reviewed annually and every effort is made to extend whenever possible. This process has enabled us to extend our support time well beyond industry expectations.

SGI's current end-of-support dates for all products are made available to contract customers and can be viewed through your SGI Supportfolio account at <https://support.sgi.com>. Please reference this website for updates to EOS dates pertaining to your products.

SGI will comply with the European Union [EU] directive on the Restriction on use of Hazardous Substances in Electronic Equipment [RoHS]. New SGI® Altix® family systems as well as SGI storage products shipping into the EU after 1st of July 2006 will be compliant with the RoHS directive. Certain of SGI's older products will not be certified under the new regulations and will therefore not be available for shipment into the EU after 1st of July 2006. The provision of spare parts is exempted under the RoHS Directive and thus maintenance and support arrangements for older products are not affected.
